

## Official Contest Rules

Occasionally, Visit Bakersfield, a division of the City of Bakersfield, will sponsor contest giveaways for tickets and other prizes. The following shall serve as rules and regulations for any contest sponsored by Visit Bakersfield, including contests via Visit Bakersfield's website and social networks (Facebook (FB), Instagram (IG), etc.).

The contest ends on Friday, February 13, 2026, at 8:00 a.m. All times in this contest refer to Pacific Time. By entering the drawing, entrants agree to waive any right to claim any ambiguity or error in these Official Rules, or the drawing itself, and agree to be bound by these Official Rules and by all decisions of the Sponsor, whose decisions are binding and final. Sponsor reserves the right to withdraw the transmission of this sweepstakes and award the prize from among entries received prior to the date of the withdrawal. Failure to comply with these rules may result in disqualification from this contest.

The contest is open to residents of California **only** and winner must be available to pick up the prize from Visit Bakersfield (515 Truxtun Ave, Bakersfield, CA 93301) by Friday, February 20, 2026, no later than 4:00 p.m.

Employees of the City of Bakersfield, parents, subsidiaries and the directors, governors, employees and agents of such entities, and the immediate family members of all such persons (spouse, parents, siblings and children), are not eligible to participate or win.

Entrant must be 18 years old or older.

You may enter by the rules outlined in the social media giveaway contest post, which will be published on Visit Bakersfield's Instagram account on Monday, February 9, 2026. Per each one (1) contest entry, entrant must like the post, follow both Visit Bakersfield and the tagged Instagram pages, and tag a friend in the comments. Each additional comment with a friend tagged is an extra entry. All requirements must be met to receive a valid entry. Likes, follows, and tags will be verified. Entrants must be using a valid and active IG account. Entries generated by a script, macro or other automated means will be disqualified. Entries that are incomplete, illegible or corrupted are void and will not be accepted.

All entries become the sole property of Sponsor and will not be returned. No correspondence will be acknowledged. Entries may be used for advertising and/or trade purposes without compensation unless prohibited by law.

Sponsor is not responsible for technical or computer failures, errors or data loss of any kind, lost or unavailable Internet connections, or failed, incomplete, garbled, delayed or deleted computer or network transmissions, inability to access any website or online service, or any other error or malfunction, or late, incomplete, incorrect, inaccurate, misaddressed or misdirected entries, or theft or destruction or unauthorized access to or alterations of entry materials, whether caused by the participant or by any of the equipment or programming utilized in this contest. If, for any reason, the internet portion of the contest is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of the contest, Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the online portion of the contest, and to disqualify any participant who tampers with the operation of the contest or website or violates these Official Rules of the contest. If the online contest is terminated due to tampering or technical difficulties prior to its expiration date, notice will be posted at [www.dignityhealtharena.com](http://www.dignityhealtharena.com), and the finalists will be selected from among all eligible on-line entries received prior to the termination date, and from non-online entries received via the methods described in section 1(b) above (which will continue to be accepted). Caution: Any attempt

by a participant to deliberately damage any website or undermine the legitimate operation of the contest is a violation of criminal and civil laws and should such an attempt be made, Sponsor reserves the right to seek damages from any such participant to the fullest extent of the law.

In the event of a dispute regarding the identity of an electronic participant, electronic entries will be deemed submitted by the authorized account holder of the email or electronic message submitted, as of the time of the entry.

There will only be one (1) prize awarded. The prize includes a Condors swag bag with a four-pack of Executive Level game tickets & other items, one (1) Gift Certificate to Locale restaurant valued at \$150.00, one (1) Gift Certificate to House of Flowers valued at \$150.00, one (1) box of assorted chocolates from Dewar's Candy, and one (1) voucher for admittance of up to two (2) people at a Music Bingo Night event. The total retail value of the prize is approx. \$510.00.

Winners will be selected through a random computer drawing from all eligible entries. The winner will be notified on Instagram by their Instagram handle provided by the winner.

The odds of winning depend on the number of eligible entries received. If any prize notification is undeliverable, or in the event of non-compliance with any of these requirements, the prize will be forfeited, and an alternate winner will be selected at random from the remaining eligible entries. The prize's value may vary in price depending on what is offered (i.e. multiple day weekend passes). The prizes cannot be exchanged for cash. Transfer of the prize is prohibited.
